V. <u>Loan Modification Request: Lexurious Transport, LLC (*):</u>

Requesting loan modification for Lexurious Transport to move start date of payments from August 1, 20222 to start December 1, 2022. Payment amounts will remain the same at \$708.33 for the first twelve months and then \$791.74 for the term of the loan.

VI. Loan Modification Request: Beauty Art By Roy (*):

Requesting loan modification for Beauty Art by Roy. Original payments were to begin on May 1, 2022, payment invoices were being sent to incorrect address. Once notified, a payment of \$2,500 was made on July 18, 2022. As a result, next payment due date is September 1, 2022. A six-month forbearance is requested to allow time for repair and resuming operation. Payments should resume as of March 1, 2023.
