A Summary Judgement against Cher-Rish Boutique and Berrica Lewis was granted in the amount of \$68,036.91, which is compromised of the initial \$58,839.00 unpaid debt, plus \$8,825.85 in attorney fees and \$372.06 in cost. After the court hearing Ms. Lewis called our Attorney and request a payment plan and offered to pay \$500.00 per month. Our Attorney confirmed approval of that amount with our office. Our Director approved the request and our Attorney drafted and sent settlement documents to Ms. Lewis. We will update once the documents have been executed an agreement is in place.
